Team Roping Partners will be drawn on July 24th for those who do not select a partner. You will be responsible for the drawn partner's \$15.00 Stock charge.

AWARDS

Total points/times from both rodeos will be used to determine the winner of each events.

All Around Saddles, All Around Runner-Up Buckles, will be determined by total points.

PAYBACK – 100% of the entry fee will be sent out after books are audited by the State Rodeo Secretary.

RULES

1. The Quay County Rodeo will be conducted according to the State 4 H Sanctioned Rodeo Rules. (Rodeo Rule Book 200 R 2024) Arena conditions may warrant changes in rules for safety of horses and youth.
2. **GROUND RULE!** Running of horses in or out of arena is strictly prohibited. **GROUND RULE WILL BE ENFORCED!**
3. **DOGS ARE PROHIBITED ON FAIRGROUNDS!** RV's or Trailers **MUST** be parked outside of the arena area. Electrical hook ups are not available. Dry camping only on fairgrounds.
4. **IN ACCORDANCE WITH NEW MEXICO STATE LAW SJC SENATE BILL 268.AA 1993, IT IS NOTED THAT THIS (QUAY COUNTY FAIR GROUNDS) FACILITY IS NOT RESPONSIBLE FOR ACCIDENTS.**
5. Please adhere to the Rodeo Dress Code.
6. Money will only be refunded with either a Vet Certificate or Doctor's Release that must be faxed to (575) 461-2899 by the time your performance is scheduled to begin.
7. It is the contestant's responsibility to be ready when scheduled and any changes will be at the discretion of the arena director.
8. **A three-call rule will be enforced.**

Be sure to check the NMLB website for the health certificate requirements.

STALL INFORMATION

STALL RESERVATIONS WILL NOT BE ACCEPTED WITHOUT PAYMENT.

PAYMENT WILL BE REFUNDED IF:

- 1) STALL RESERVATION IS CANCELLED, ONE (1) WEEK IN ADVANCE
- OR 2) CONTESTANT CANCELS DUE TO INJURY OR ILLNESS (**must be certified in writing by physician and/or veterinarian**).

Stall assignments will be posted prior to horses' arrival in the stall area. STALLS MAY NOT BE SWITCHED.

All questions and problems are to be directed to the STALL MANAGER. Stall renters must furnish their own feed and feeding and watering tubs. Tack rooms are Not available, no exceptions.

OUR STALLS ARE A PERMANENT OUTDOOR FACILITY WITH LARGE STALLS AND PARTIAL COVER.

(Approximately 18'x12') **Stalls are limited to 70 stalls; get your reservation in early.**

No trailers will be allowed in the stall area due to lack of turnaround space. You may use your pick-up in the stall area.

The gate on Camino Del Coronado (West end of stalls) will be locked. Trailers and trucks are to be parked on the **WEST** side of the fair barn. You may feed at your trailers. Please police your area in the parking lot for trash.
